Note that in some locations, logo sign leases may be only available in one direction on the mainline highway. The highest bids will be assigned initially to the bi-directional leasing locations, and then the remaining uni-directional sign spaces, if any, will be assigned to the remaining bidders in order of descending bid amounts at a rate of ½ (half) of the bid amount submitted per the "second price" or next lowest bidder, and so on through the bids for the available uni-directional signage space.
